# Last Quarter Highlights....

#### Flows

- Significant progress by fish/flows WG, supported by CVRD, to develop science based fish flow regimes for Cowichan River
- Successful CVRD proposal to fund further development of science based flow regimes for

### **Technical**

- Re-invigorated and engaged working groups (new members and workplans)
- Partnership with MOE, CCLT, Cowichan Tribes
  created to implement 2017 Cowichan Koksilah WQ
  sampling program (REFBC funding)
- Agreement with TimberWest and Riparian WG members to host private land forestry tour next quarter. (as follow up to Forest Hydrology workshop)

### Governance

- Meeting with MOE Minister Polack and FLNRO Minister Thomson resulting in tentative agreement to work together to implement components of local governance proposal
- Agreement with Water Funders Collaborative with support from POLIS Project, to work together to more clearly define role of CWB vis a vis local government, Cowichan Tribes and Province of BC.

Proposal developed, by invitation, to BC Freshwater Legacy Fund for the above.

### Planning/Administration

- Completion of bilateral interviews with Cowichan Watershed Board members and associated outline for CWB strategic plan moving forward
- Creation and Ratification of 3 year Budget
- Strategic Planning with CSRT regarding roles and responsibilities
- Secured funding for 2 Canada Summer Job grants to support outreach team.

## Focus This Quarter...

### - Flows

- •Complete work with FLNRO, DFO, Cowichan Tribes and recreational sector on target and minimum fish flows to support CVRD lead SDM process.
- •Engage and support CVRD Structured Decision Making Process to clearly define required Cowichan River flow regime to support ecological, cultural, industrial, agricultural and recreational values.
- •Work with FLNRO, Cowichan Tribes and others to define "critical flows" for Koksilah River



### **Technical**

- Support to TAC and working groups:
  - "5 year checkup" Strategic Evaluation of CWB Targets
  - FIsh/flows
    - Structured decision making process on river flows
  - Conservation

### Governance

- Develop sustainable funding mechanisms with Sustainable Funding for Water Governance Initiative
- Utilize resource provided by the BC Freshwater Legacy Fund to work to more clearly define relationship between CWB and major partners – CVRD. Cowichan Tribes, Province of BC, Govt. of Canada
- Follow up on work with Province of BC to implement agreed upon elements of "new relationship"
- Strategic planning
  - Strategic plan for reviewing/updating targets
