# BC Freshwater Legacy Initiative July 31, 2017



## Local Governance Background...

- Pursuing local decision making through proposal to the province of BC was supported by Cowichan Tribes, CVRD and the CWB
- There were some legitimate concerns expressed and issues highlighted by CWB Members:
  - Is this drawing resources away from work on flows and other tech projects?
  - How much is this going to cost?
  - What's the role of the CWB we aren't really a formal entity
  - What about our partners Cowichan tribe's rights and title, CVRD's mandate under the municipal act – how is all this supposed to work
- These concerns have been acknowledged and reflected in our approach

#### BC Freshwater Legacy Initiative Background

 Have reached an agreement that will see the initiative provide the CWB with 200K over 18 months. The money will be delivered in 4 envelopes to enable 2 pieces of work.

#### • The Work:

- First, it will enable us to host facilitated workshops between CVRD, Cowichan Tribes and the Cowichan Watershed board to more clearly define our roles with respect to water and watershed management and how we can more effectively work together respecting rights and title and the CVRD role as defined by the municipal act.
- Secondly, it will provide resources to continue to explore a partnership with the Province of BC as defined under the water sustainability act.



#### BC Freshwater Legacy Initiative Background

- The Money 4 envelopes....
- Cowichan tribes to provide for a project lead for water and watershed governance
- CWB Additional staff time to ensure no drain on time/resources dedicated to flows/technical work
  - 2 external facilitators to plan and implement our workshops.
    - Sr. Facilitator
    - Local Jr. Facilitator to provide local perspective and build capacity within our community
    - free up the partners to fully participate without having to run the process
  - 4th envelope is for direct costs associated with meetings, meals, venues etc.

  - Begin to develop strategies to address challenges
