- b. Oliver Brandes, Advisor to CWB has been appointed co-chair to the The International Joint Commission (IJC)'s newly formed International Elk-Kootenay Watershed Study Board. This group convenes experts and knowledge holders to conduct transparent and coordinated transboundary data and knowledge sharing to support a common understanding of pollution within the watershed and its impacts on people and species.
- c. Jenna was able to provide funding from her department to Cowichan Tribes for WQ low flow monitoring. Lots of issues heaving rainfall, migration in other systems. Resources on standby feel free to reach out to Jenna.
- d. Tim good news. Fri-Sun CT fisheries staff out in estuary chum fishery with coho bycatch. For the first time in a number of years, the run should easily meet escapement targets. Might even be an economic opportunity for Quw'utsun community members.

 Report: <u>Assessing the Impacts of Nonpoint Source Pollution in the Cowichan River</u>
 Liam presented a slideshow and took questions about his study.

Updates:

- Board Member Dr. Shannon Waters, Board Advisor Oliver Brandes and Danni are meeting with representatives from the Okanagan Nation Alliance who are looking to develop a similar board structure with their local municipality. If any other Board Members are interested in sharing about the work of the CWB with other Nations and, of course, learning from them about what they have going on in their communities, please let Danni know.

- This year we plan to tackle a revamp of the website. We will be reaching out to you as Board members for guidance along the way to ensure it is reflective of the diverse knowledge that is brought to this table of leaders.
- CWB was awarded funding from the Watershed Security Fund! This funding will help us to do
 our core work with a priority on growing the team with Indigenous and non-Indigenous youth
 as tomorrow's leaders in watershed stewardship. It will allow us to root this unique form of
 collaborative governance and partnership systems as the foundation of how we work for our

watersheds and the natural world in the Cowichan Valley. Danni acknowledged this was years in the making and a huge effort on the part of current and past Co-Chairs, Board Members and staff.

Decisions/Guidance:

A. The staff has identified we could support conversations around forestry and the Private Managed Forest Lands within the Xwulqw'selu Watershed Planning process. We would take guidance and leadership from Cowichan Tribes in terms of moving these conversations forward. Is there any objection to us exploring this piece of work?

Guidance: Alison — important for the CWB to be involved; general agreement around the table.

B. We would like to host a luncheon after the next meeting. Are folks in favour? Guidance: Majority said yes, then requested to send Danni any dietary requirements.
